As a result, ENHANCE is extremely clean, containing no unwanted sodium and chlorides that negatively affect growth and productivity. ENHANCE is a highly soluble, clear liquid formula, held in solution for effortless applications and fantastic results.

DIRECTIONS FOR USE

ENHANCE can be applied to most field crops, row crops, vegetable, cucurbit crops, deciduous fruit and nut trees, citrus, grapes, berries, olives, and avocados.

FERTIGATION APPLICATION RATES

Apply 5-25 gallons per acre per irrigation. Continue irrigation for a minimum of 2 hours after application to maximize nutrient distribution with drip and micro-sprinkler use. Repeat applications will be beneficial.

FOLIAR APPLICATION RATES

Apply 1-3 gallons per acre. The minimum water volume is 10 gallons per acre by air. The minimum water volume is 20 gallons per acre by ground. Do not apply this product when temperatures exceed 90°F.

FIRST AID
